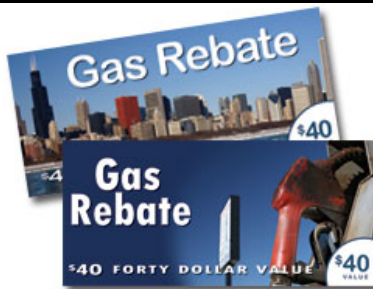


Gas Rebate

Rules and Authorization Form

MFT, Inc. Rules For Gas Rebate Offer:



1. Gas Rebate program is administered by MFT, Inc. MFT, Inc is not affiliated with Allstate Insurance Company or King Financial Services. Your participation in the program is subject to their terms of service.
2. Strict adherence to all rules is required, or coupon is invalid. This offer gives you four \$10 Gas Rebate coupons, the first of which is at the end of this form.
3. You must fill out and return the attached Registration Validation Form with the appropriate authorization code along with your registration fee to activate your account before you can use your coupons.
4. You must register your Gas Rebate Offer within 15 days of the authorization date of offer is void. The authorization date is the date you receive your authorization code.
5. You must mail your registration form and fee to us to activate your rebate. Registration must be postmarked within 15 days of authorization date. Forms received incomplete or without registration fee will be voided and not returned.
6. You must wait thirty (30) days from the authorization date before redeeming your first \$10 rebate coupon. Coupons received prior to 30 days from issue date will be voided.
7. A legible sales receipt for a gas or diesel fuel purchase in the exact amount of the coupon from a fuel retailer must be included with the coupon. A fuel receipt can be for fuel only.
8. Coupons may not be combined. Only one Gas Rebate Offer per household per year may be redeemed.
9. Only one coupon may be redeemed within a 30 day period. If multiple coupons are submitted, only one will be fulfilled and all others submitted will be voided.
10. If your fuel receipt is valid, we will mail out your rebate check with another coupon until your offer is completed.
11. Coupons may be redeemed only by mailing the coupon and fuel purchase receipt to the address provided. Coupons have no retail value and will not be accepted by the fuel retailer.
12. Coupons that are mailed without a valid fuel receipt will not be returned, and the request for redemption will not be fulfilled or acknowledged and will void the remaining coupons.
13. Coupons or coupon booklets will not be replaced if lost or stolen.
14. No copies or duplicates will be accepted. Certificates may only be used by the registered consumer. Only the original coupon book or offer is valid.
15. The envelope in which the coupon and receipt are mailed must be postmarked within 7 days of the fuel purchase. Submitted requests which exceed the 7 day postmark restriction will not be honored or acknowledged.
16. This offer is void where prohibited by law. Allow approximately 4 to 6 weeks for delivery of your check.
17. Coupons have no cash value other than through redemption at the address indicated on the coupon.
18. All coupons must be redeemed within 8 months from the authorization date.
19. All blanks on coupons and on the registration form must be filled out completely and correctly (especially the authorization date) or the offer is invalid.
20. We reserve the right to terminate this offer without notice and offer the consumer other incentives of equal or greater value.
